School Regulations

The adherence to these School Regulations ensures a smooth and correct functioning of the school. They form part of this Tuition Contract.

- Registration** for tuition shall be made in writing. For registration of an applicant who is a minor / under-age, then this contract shall be signed by a parent or legal guardian, and shall be legally binding after confirmation by the music school. **Admission** to the music school shall start on the first day of any month, but is subject to the availability of tuition places.
- The student is required to attend **lessons regularly** and to carry out any given assignment to the best of his/her ability.
- The charged **tuition fees** are in accordance with the Tuition Fee Regulations below. They are part of this Tuition Contract and based on 37 lessons per calendar year. The tuition fees are fixed for one year, defined by the Yearly Fee and shall be paid quarterly (on the 15th of the second month of the quarter) by bank direct debit.
- The school year is defined according to the **holiday regulations of the state of Hessen** (hessischen Ferienordnung). The business year corresponds to the calendar year. For any **movable holidays** then the holiday regulations of Dreieich town apply.
- Termination of Tuition.** Within the first 2 months from the start of tuition, there is a special notice period granted allowing the tuition to be terminated as at the end of the 2nd month. After this time, tuition can be ended according to Point 6 – Termination of Tuition.
- Tuition can only be terminated by the student or the music school on 31st March or 30th September, with written notice 4 or more weeks in advance.
- On a **change of address** (proof required) or a **long illness** (doctor's confirmation required), the notice period is 4 weeks within the school year.
- A **reduction of tuition fees** may be granted in cases of hardship (appropriate proof required).
- If the **music teacher is ill** the school management will attempt to find a replacement to hold or repeat the lesson(s). If this is not possible, and as a result 37 lessons cannot take place within the calendar year, then tuition fees for those lost lessons will be credited. Lessons not attended by the student are still required to be paid for.
- If a lesson is cancelled due to unruly behaviour, then the tuition fee for the lesson is not credited, **even if this is not the fault of the student.**
- A student may be **excluded from a lesson** because of: irregular lesson attendance, improper behaviour or the non-payment of tuition fees. Tuition fees shall be charged up to the point of any expulsion date. In extreme cases the student may be expelled immediately from the music school.
- A **change of teacher** is only possible after arrangement with the school management.
- If it is desired to record the lesson, then it is advisable to talk to the teacher about the provision of a suitable instrument.
- Public performances** and any registration for competitions by the student in a subject taught to the student by the school shall be agreed in advance with the school management.
- The school management shall be informed personally or in writing of any **complaints**.
- Any **agreements with the teacher**, that would otherwise contradict the Tuition Contract, are not legally binding

This **Tuition Fees Regulation** is valid from 01.01.2015 **Place of fulfilment is Dreieich and Court of jurisdiction Langen.**

The tuition fees for Project „fürUNS“ shall be as the above Tuition Fees Regulation , but with a 25% reduction (no further reduction for this subject is allowed!)					

Reductions :

- For the student's 2nd subject or the 2nd family member 20%
 For the student's 3rd subject, or the 3rd family member 30%
 For the student's 4th subject, or the 4th family member 40%
 For the student's 5th subject, or the 5th family member 50%

At any given time, the subject with the highest lesson fee has no reduction. Each other subject is then taken in order of descending fee, and the reduction applied according to that position. This reduction mechanism does not apply to choir fees. Choir fees are reduced by 50% by attending an instrument course.

Musical Instrument Rental:

- 1st to 6th month: from € 20 / month
 from 7th month: from €35 / month
